**ADDITIONAL INSTRUCTIONS:**

It is very important that you update your mailing and residence address as soon as possible. Renewal notices are printed a few months ahead of time and with the volume of address changes, they are not always entered in time for you to receive a renewal notice. If it is within 4 months of the expiration date of your registration when you are completing the form, you may wish to hand deliver the notice to DMV or contact DMV for procedures on renewing without a renewal notice.

When requesting a change of address for your vehicle, you must enter each vehicle, trailer, snowmachine, or ATV separately. In the space titled "Last 2 digits of VIN / HIN", enter the last two digits of the serial number or vehicle identification number (VIN).

For boats, enter the boat number and the last two digits of the hull identification number (HIN).
