PROCEDURE FOR A DUPLICATE COLORADO TITLE

To comply with Colorado Laws this procedure is to be followed when applying for a Colorado duplicate title.

STEP	WHAT YOU NEED TO DO	FORM NEEDED
1	A Colorado resident or a business located in Colorado must apply for duplicate title at the local county motor vehicle office. Contact your county office for the proper form.	
2	Complete and sign the duplicate application (DR 2539 A). Applications are verifications of ownership and must be signed by the owner, lienholder, or authorized agent.	DR 2539 A
3	Colorado duplicate titles can only be applied for by the owner, lienholder, or authorized agent. If the authorized agent applies for the duplicate, he must submit a power of attorney signed by the owner or lienholder. Power of attorney forms are available at the county motor vehicle office, or the state title section. Upon request, a power of attorney form will be sent.	DR 2175 Power of Attorney
4	The fee for a duplicate Colorado title is \$7.50. Please submit separate applications and fees for each request.	Fee \$7.50
5	<p>Please note: Liens are shown on the Colorado title for eight years. If a duplicate is applied for during that eight years, the title is automatically sent to the lienholder. The lienholder upon receipt of the title shall:</p> <ul style="list-style-type: none"> • If the lien is satisfied, release the lien on the duplicate title, and forward to the owner. • If the lien is still in effect, retain the title until the lien is paid. <p>If a duplicate title is applied for and a notarized lien release is included with the duplicate application, DR 2539 A, the title will be mailed to the owner. It is the responsibility of the owner to have the lienholder release the lien on the face of the title.</p>
