INSTRUCTIONS

VEHICLES:

To release a lien on an existing title, please complete this form and send it with the existing title to the Department of Motor Vehicles with the \$10.00 fee. If this form TA-VT-08 is received along with an application for DUPLICATE TITLE there is no fee to release the lien, only a \$10.00 fee to produce the DUPLICATE TITLE.

REQUIRED FOR ALL TITLEABLE VEHICLES (ONLY):

A meter reading is required if the vehicle is (less than 16 years old based on VIN model year) titleable. If vehicle is not so equipped, a statement to that effect is required. Statement must describe vehicle by MAKE, MODEL, YEAR and VIN (serial number). All readings must be in whole numbers categorized as miles, kilometers or clock hours or application will be returned.
