INSTRUCTIONS FOR COMPLETING SNOWMOBILE APPLICATION

Please print with a ball-point pen or use a typewriter. **DO NOT USE A PENCIL.** Complete all areas that are applicable.

EXPIRATION DATE

Annually at midnight on the last day of August. Applications received within 30 days of the end of the current registration period will be issued to expire at the end of the subsequent registration period. NOTE: A registration is valid only when a registration certificate (temporary or regular) has been issued. [An Antique Snowmobile registration is permanent with no expiration date.]

NOTE: TO NON RESIDENTS - Registration reciprocity is granted to a snowmobile registered and numbered by any other state or province (provided a valid Vermont "Trails Maintenance Assessment" decal issued by the Vermont Association of Snow Travelers is also displayed adjacent to the registration decal on the left side of the snowmobile). SUPPORTING DOCUMENTS REQUIRED: (Please note that supporting documents will not be returned.)

1.) First registration of snowmobile in Vermont in your name:

- ♦ Signed bill of sale describing the snowmobile by identification number, make, year, date of sale, purchase price and seller's signature **OR** ♦ Seller's signature in Section 5 of application **OR**

2.) Transfer:

- ♦ The current registration certificate of the snowmobile from which you are transferring the ownership, if available. The "Notice of Transfer" section must be completed.
- ♦ If the registration certificate is missing, any source document describing the snowmobile transferred by year, make, identification number, date of sale and name and address of new owner **OR** the completion of Section 8 will be accepted.

ANTIQUÉ SNOWMOBILES: 23 V.S.A. ss.3204a. (effective July 1, 2000) (a) The one time registration fee for a snowmobile that is at least 25 years old and is used exclusively in exhibitions, parades, and public functions shall be \$42.00. The registration process for snowmobiles registered under this section shall be the same as provided in section 3204 of this title. (b) The owner of a snowmobile that satisfies the criteria established in subsection (a) of this section shall be entitled to display antique snowmobile plates that shall be distributed according to rules adopted by the commissioner.

INSTRUCTIONS BY SECTION:

Section 1	<u>New Registration Box</u> - check if you are registering the snowmobile for the first time in Vermont in your name. <u>Transfer of Registration Box</u> - check if you are transferring a VT registration to another snowmobile owned by you. <u>Renewal of Registration Box</u> - check if you are renewing the registration. Please enter the last VT registration #.
Section 1A	<u>Antique Snowmobile Box</u> - check box D. ALSO CHECK APPLICABLE BOX IN SECTION 1. ABOVE ie. A., B., or C.
Section 2	Complete all areas. If no identification number is present, make application to the Department of Motor Vehicles for assignment of an identification number on form TA-VT-03 and submit along with this application.
Section 3	Complete all areas. Include legal address if different from mailing address. If mailing address is a Post Office Box or Rural Route you must show legal address. Social Security Number - if none write "none". If a business, use Fed. ID # in place of SSN.
Section 4	Dealer Use Only.
Section 5	Required for first registration in your name of your snowmobile in Vermont. Signature is not required if it is on a supporting document (a properly assigned bill of sale) or if the snowmobile was registered to you previously (Submit a copy of the registration.)
Section 6	Check box if applicable (see non-resident below).
Section 7	To be completed by V.A.S.T. Agent or Dealer only for temporary registration. Agent/Dealer must date, sign, indicate Agent/Dealer #, and circle whether Dealer or Agent. VT dealers may only issue registrations for snowmobiles that they sell. If signed by a VT dealer for a snowmobile not purchased by the registrant from the Dealer, Dealer must also be a V.A.S.T. Agent and must list agent number indicating this is a V.A.S.T. transaction by circling V.A.S.T. agent # and V.A.S.T. Agent signature. VERMONT RESIDENT: A sales tax of 5% is due at time of registration unless the registrant has obtained an exemption letter from the Vermont Department of Taxes. A credit of up to 5% will be given for sales tax paid in another state if proof of purchase showing the amount of tax paid is presented with the application. NON-RESIDENT: <i>Eff. 3/18/97 - No registration or tax is due if snowmobile is currently registered in home state/province.</i> If not currently registered in another state, and applicant will use snowmobile in VT, registration is required. No tax is due if registrant presents a valid /expired registration from his/her home state/province. No tax is due if non-resident purchases a snowmobile in VT and takes delivery out-of-state. If delivery is taken in VT, sales tax is due. No tax is due if snowmobile is purchased out-of-state by a non-resident.
Section 8	EXEMPTIONS: Religious, charitable or educational organizations may be exempted by the VT Department of Taxes. For further information regarding the tax contact the Sales & Use Section of the Tax Department (802)828-2551. TAXABLE SNOWMOBILE TRANSACTIONS MUST BE ACCOMPANIED BY TAX FORM SU-452 UNLESS THIS IS A VT DEALER TRANSACTION AND SECTION 4 IS COMPLETED. (Form SU-452, Vermont Use Tax Return (available from VT Department of Taxes and the Department of Motor Vehicles.)
Section 9	Must be signed and dated by all owners.
Section 10	Registration Fee - See fee schedule above. Tax Due = 5% of purchase price minus allowable credit. Transfer Fee - when transferring valid VT registration to another snowmobile. Total of above fees.
